DICSA and RSVP are considering providing an AARP Driver Safety Program for our senior population. Before we do, we'd like to hear from you. We want to know if people in the area would be interested in attending the class. To summarize, this is an 8 hour course designed as a driver refresher for age 50-plus. The class is held either as a one day session (8 hour), or as a two day, consecutive sessions (4 hour each day.) The goal is to help older adults continue driving safely for as long as possible. As an example, the material covers current rules of the road, age-related changes in adults, importance of eliminating distractions while driving, vehicle features and technology, as well as ways to monitor your own driving skills and capabilities. This course complies with all requirements of the Michigan Public Act 610 (section 500.2111a). This course will refresh your driving skills and bring you up to date on the latest technology available in newer vehicles and with all the new laws and may help you navigate through a roundabout. The course cost is \$15 for AARP Members and \$20 for Non-Members, payable to the Instructor in cash, money order or personal check made out to "AARP" on the first day of class (no credit cards). The participants must bring their Michigan driver license and AARP card, if they have one. The participant may be eligible for a discount on their auto insurance (they need to contact their agent to find out).

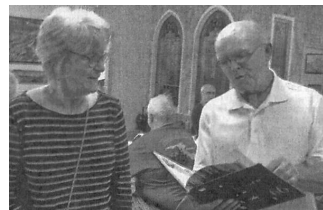


Jeanne, the Executive Director for the Iron Moun-

Issue Number: Tax Tip 2019-134

Taxpayers should beware of property lien scam

With scam artists hard at work all year, taxpayers should watch for new versions of tax-related scams. One such scam involves fake property liens. It threatens taxpayers with a tax bill from a fictional government agency.

Here are some details about the property lien scam that will help taxpayers recognize it:

- This scheme involves a letter threatening an IRS lien or levy.
 - The scammer mails the letter to a taxpayer.
 - The lien or levy is based on bogus overdue taxes owed to a non-existent agency.
 - The non-existent agencies might have a legitimate-sounding name like the "Bureau of Tax Enforcement." There is no such agency.
 - This scam may also reference the IRS to confuse potential victims into thinking the letter is from a real agency.
- For anyone who doesn't owe taxes and has no reason to think they do should:

Contact the Treasury Inspector General for Tax Administration to report the letter. The taxpayer should use their [IRS Impersonation Scam Reporting](#) web page. When reporting the scam, they should include the key words "IRS Lien."

Scan a document received as a letter or fax, and send it to phishing@irs.gov.

Report it to the Federal Trade Commission using the [FTC Complaint Assistant](#) on FTC.gov.

Report it also to the FBI's [Internet Crime Complaint Center](#), known simply as IC3.

Taxpayers who do owe tax or think they might owe should:

Review their [tax account information](#) and [payment options](#) at IRS.gov. Reviewing tax account information online will show the taxpayer if they indeed owe the IRS and how much. This is the fastest way to get this information.

- Call the IRS at 800-829-1040 to confirm the notice if they're still not sure they owe.

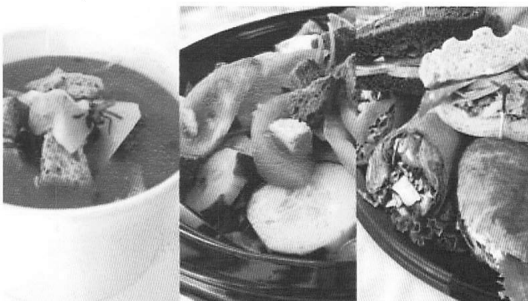

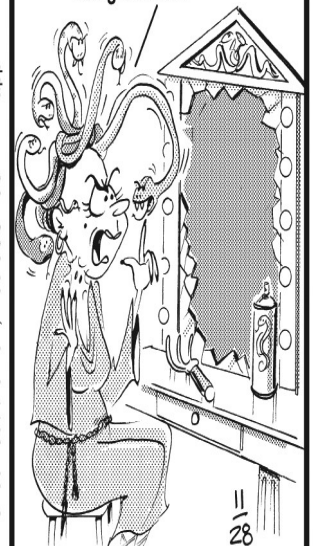
